### Nevada County Fairgrounds RV Park

The South Park RV Campground is located on the Fairgrounds property with easy access from the crossroads of State highways 20 and 49 in Grass Valley.

We have 44 full hook-up sites and approximately 100 sites with water and electric hook-ups available for individual and group RV camping. Restrooms, showers and two convenient dump stations are located in the RV Park. Individual camping is on a first-come, first-serve basis. Reservations are always encouraged.

### RV Camping Rates

affective May 1, 2007

Full RV hook-up sites \$28 per rig/per night

Water/electric sites \$24 per rig/per night

Group RV liability insurance \$30 up to 100 sites

- One week maximum stay for individuals subject to availability
- Reservations may be made by telephone with a credit card. Cancellations must be received 48 hours prior to arrival to avoid charges
- A deposit of 1 night/rig is required for all group reservations
- Proof of vehicle insurance required
- RV groups subject to insurance surcharge of \$30-\$60 unless covered by a group policy.
